Introducing the IPRO ESRD Network Program

The Centers for Medicare & Medicaid Services (CMS) oversees 18 regional End-Stage Renal Disease (ESRD) Network organizations across the country. Each Network works to improve the quality of healthcare services and the quality of life for patients with ESRD. The IPRO ESRD Network Program serves all individuals with ESRD in...

- The states of Connecticut, Maine, Massachusetts, New Hampshire, Rhode Island, and Vermont (IPRO ESRD Network of New England—Network 1);
- New York State (IPRO ESRD Network of New York—Network 2);
- The states of Georgia, North Carolina, and South Carolina (IPRO ESRD Network of the South Atlantic—Network 6); and
- The states of Indiana, Kentucky and Ohio (IPRO ESRD Network of the Ohio River Valley—Network 9).

The mission of the IPRO ESRD Network Program is to promote healthcare for all ESRD patients that is safe, effective, efficient, patient-centered, timely and equitable.

- Empower and engage patients to become educated consumers and partners in their healthcare;
- Improve quality of care for all ESRD patients;
- Collect data from dialysis and transplant facilities to measure quality of care;
- Assist you, your family members and care partners, and ESRD facility staff in understanding the CMS ESRD Quality Incentive Program;

- Develops and provides educational materials for you and your family;
- Works with renal professionals to improve the care given to you;
- Helps keep you informed and updated to support your involvement in your care and treatment options; and

- Resolve grievances that cannot be resolved at the dialysis facility level.

Network Regional PAC Chairperson (PAC Chair) - Network Level

- Answer patient and provider questions regarding Network activities.

Network and National Patient Subject Matter Expert (SME) - Network and National Levels

- Assist the Network in guiding quality improvement and educational activities at both the Network and national levels.
